Planning and health programmes

Throughout 2006, the Autonomous Communities have developed their activities in the area of health, establishing their own priorities and their own plans and programmes without sacrificing their adhesion to state-wide legislation, and always within the framework set out in basic laws (table VIII).

Besides the plans and programmes already in existence in each community, and which have continued their development through specific dispositions and rules in 2006, there have been new ones passed which, in general, are more sectorial and address specific health problems or aspects within the respective health systems. There have also been isolated cases of general or transversal plans approved in health matters, such as in Valencian Community⁵⁹.

Among the Autonomous Communities who have made more use of these planning tools in their health actions, Catalonia stands out with 6 specific plans, followed by Andalusia with 4 and Madrid with 3.

One of the main areas in which the Autonomous Communities have focussed their planning activities has been that of cancer, in terms of control and care (Catalonia⁶⁰ and Madrid⁶¹); while there have been other more specific actions (breast cancer in the Canary Islands⁶²).

Another health issue which has seen planning activity has been the flu, with the approval of specific instruments, in the case of Castile and Leon⁶³, while most of the Autonomous Communities have tackled this health problem by creating organs for its prevention, control and monitoring.

Other plans by Autonomous Communities to tackle specific health issues include the AIDS plan of the Balearic Islands⁶⁴, Alzheimer's disease and rapid treatment for youngsters with developmental issues in Andalusia⁶⁵ and diseases of the circulatory system and mental health in Catalonia⁶⁶.

Planning has also been applied in areas such as mental health and in the social and sanitary area in Catalonia⁶⁷, and occupational health and health education in Extremadura⁶⁸.

As regards organisation and management, plans have been approved dealing with prevention and care in situations of conflict with the public (Madrid⁶⁹), and the treatment of ill health care workers (Andalusia⁷⁰ and Madrid⁷¹) as well as immigration and cooperation (Andalusia⁷² and Catalonia⁷³).

Finally, the planning of the autonomies has also centred on the development of research, both in general (Catalonia⁷⁴) and in specific areas, such as cell therapy and regenerative medicine (Andalusia⁷⁵).
